Scope

Description

As above, the UK7 Summary screen displays "Publish" and "Preview notice" when sections are incomplete, which then, unsurprisingly, results in a submission failure.

It occurs when all sections except Contracts are completed, and the draft notice is saved. When returning to the draft notice, the summary screen displays as the example above. If the user views Contracts, but doesn't select any contracts in the picker, the section is still displayed as completed in the summary screen.
